### **Members in Attendance**

A total of 47 Ordinary and Life Members were in attendance—39 physically and eight virtually. The meeting was also attended by three Associate Members and one former member. The number of eligible voters was three short of a quorum (50). In accordance with Clause 6.1 (viii) of the National Constitution, all decisions made at the AGM, remain interim until ratified by a majority of the SAA branches within three months of the AGM. A list of the members attending is attached as **Annexe B.** 

### 1. **Open Meeting.**

The meeting was called to order at 1008. The National President addressed the meeting, first thanking the President of the SAA NSW Branch, Geoff Anderson, and his committee for the excellent program of events over the SUBCON 2025 weekend. He reflected on the many members who had "crossed the bar" over the last year, paying tribute to the unseen work of National and Branch Committee members in assisting the families of the deceased. David also highlighted the potential to grow the SAA membership base in Western Australia, with up to 500 US personnel soon to be deployed there in support of *AUKUS*.

### 2. Tribute to departed comrades.

Tony Vine read the list of the twenty two submariners who are known to have "Crossed the Bar" since SUBCON 2024. This was followed by the reading of the Naval Ode - Lest We Forget. The list is attached as **Annexe C**.

#### 4. Confirmation of the Minutes of the National AGM held 13 October 2024.

The previous AGM 2024 was held in the Maroochy RSL. The minutes of the 2024 AGM have been available online and were previously emailed to all branch Secretaries for dissemination to members.

The Secretary called for the minutes to be accepted as a true record of proceedings.

### 5. Business Arising from the Previous Minutes

There was one action item arising from the 2024 AGM.

- a. The incorporation of constitutional changes agreed at the 2024 AGM into the National Constitution. This action was completed with the publication of Amendment 7 to the National Constitution dated 13th of October 2024 **Action Complete.**
- 6. Reports.
- a. **Treasurer's Report.** The National Treasurer, John Rana tabled his report, Annexe D, read by Sid Czabotar on his behalf. The report indicates that the Association is on a sound financial basis and that current subscriptions and joining fees are adequate and there is no need to increase them. The Reviewing Officer's report indicates that the documents presented to him accurately reflect the receipts and payments of the SAA. There will be a disbursement of \$500 per branch (Excepting Tasmania). The full report is attached as **Annexe D**.

- b. **Presidents Report**. The President, David Strangward AM, tabled his report. He praised the organisation of last year's SUBCON by the Queensland Branch and thanked NSW for taking up the challenge of hosting SUBCON 25 after SA withdrew. He thanked Bob Hendrie for his work with the website and brought to the attention of members the growing suite of policy documents on the SAA website. Among other items, he highlighted the difficulty in recruiting members for executive roles and emphasized the need for succession planning across all levels of the SAA. He noted that this situation is exacerbated by members who criticise management from the sidelines without offering meaningful solutions. The full report is attached as **Annexe E**.
- c. **Vice President's Report.** The Vice President, Tony Vine, tabled his report and briefed the AGM on the suite of SAA policies developed to assist Branch Executives in meeting the Association's

objectives. He highlighted the policy on procedures following the death of a member as a key example. He briefed the committee on the issuing of "Dolphin Poppies" to the partners and children of deceased submariners but noted that the issue is not retrospective. He emphasised the need for members to update information such as email, phone numbers and addresses to assist the Secretary, Treasurer and Membership Officer. Along with the Webmaster he will investigate the creation of a form on the SAA Website to facilitate this. The full report is attached as **Annexe F.** 

**Action 2025/1:** Webmaster (Bob Hendrie)/National Secretary (Tony Vine) to implement, if possible, a "change of contact details" form on the website.

d. **Acting Secretary's Report.** The Acting Secretary, Tony Vine table his report for the period 14 July to 26 October 2025. He also tabled the SAA Correspondence Register for that period for acceptance by the meeting. The full report is attached as **Annexe G.**

e. **SAA Welfare Successor Foundation Report.** The Welfare Foundation Chair, David Bryant tabled the 2024/25 Financial Report on behalf of his fellow Trustees Zladislaw (Sid) Czabotar and Kevin Hayton. David thanked the members for the significant financial contributions made to the fund over the last year, particularly the donations made by individual members of the ACT Branch in memory of the late Life Member Peter Knights. Trustee Kevin Hayton thanked those present for the over \$1000 raised over the previous 36 hours at SUBCON for the Welfare Fund. The report is attached as **Annexe H.**

f. **Webmasters Report**. Bob Hendrie addressed the meeting on the state of the website, highlighting the improvements made over the past year. He expressed concern that he is running out of storage space for current and legacy images. To address this, he will consult with the internet provider to determine the cost of expanding the site's capacity. The National Secretary thanked Bob for his work and noted that funds remain available from the Thales grant, which can only be used for website expenditures.

Action 2025/2: Webmaster to investigate cost and availability of expanding the site.

**Post Meeting Note**: The cost has been ascertained and being \$483.12. The National Committee has approved the expenditure.

g. **Facebook Administrator's Report.** Peter O'Donohue addressed the AGM advising that he has analysed the makeup of the SAA Facebook Group members and that less than a third are SAA Members. In conducting the review, he has culled out numerous group members who are not SAA Members and who have never posted to the site. He has also removed several Fb Group members who are deceased.

### 8. Determination of Subscription Fees

The Treasurer advised that the National Executive has determined that there was no need to increase the level of Subscription Fees.

### 9. Address by the Director of the Sea Power Centre, Captain Alastair Cooper, RAN.

The National Secretary proposed the suspension of Standing Orders to allow the Director of the Sea Power Centre, Captain Alastair Cooper, RAN, to address the meeting. The AGM agreed, and the National Secretary provided a formal introduction of Captain Cooper.

### **Background**

For many years, the Royal Australian Navy's (RAN) artefacts were housed on Spectacle Island, west of Cockatoo Island. This situation was less than satisfactory, as the storage facilities were not climate controlled. Furthermore, heavy metal contamination was discovered throughout the island within the last five years. Consequently, the RAN initiated a project to catalogue the collection and relocate as much of it as possible off the island.

### **RAN Policy on Historical Collections**

RAN policy is to use a hub and spoke approach to telling the Navy story. Rather than operating public-facing museums, with the sole exception of the Fleet Air Arm Museum at HMAS Albatross, Navy seeks partnerships with public facing cultural institutions (such as the Australian National Maritime Museum, the Australian War Memorial, the WA Maritime Museum, the Submarine Museum at Holbrook, etc) to support telling the Navy story to as broad an audience as possible. Navy actively seeks to provide expertise and artefacts to support this approach. The service's historical collections and museums, now termed Heritage and Learning Centres, will be inwardly focused, aimed at educating RAN personnel to use history and heritage as a body of professional knowledge to increase their ability to solve problems and be better at the role in Navy.

### The Spectacle Island Collection & Assessment Process

The Spectacle Island collection contains numerous items of limited heritage value, including duplicate objects, such as 24 Sea Cat warhead covers, and hundreds of sporting trophies dating back a century. The entire collection is now being assessed for its significance to RAN history by specialist curators. The Sea Power Centre will also reach out to relevant interest groups to assist in this evaluation. A key principle guiding this work is that age alone does not confer historical significance. The RAN will only retain items of clear significance with meaningful future display potential; the remainder will ultimately be disposed of.

### **Conclusion**

Following his address, Captain Cooper took questions from the floor. The President thanked him for his attendance, after which the AGM resumed.

#### 10. **Notices of Motions**

**Note:** The National President formally vacated the chair to speak to his Motion. Ray Clarke (WA) assumed the role of Chair.

a. **Motion 1. - Future of SUBCON** – Submitted by National President David Strangward. The National President spoke to his motion. He spoke of the difficulties of obtaining sponsorship and having enough members to run a SUBCON. He also noted that the constitution needs to be amended to provide for instances where that it is not feasible for a Branch to host a full SUBCON. The motion was put to the vote.

**Poll;** 46 For, 1 Against **Motion**: Carried

Action 2025/4: A Working Group, chaired by the National Secretary be stood up to develop proposed constitutional changes to provide flexibility of when SUBCON is held. The changes are to be the subject of a motions at the 2026 AGM.

**Note:** The National President resumed the chair.

b. **Motion 2. Recognition of deceased Life Members on the Submariner's Walk**. Submitted by National Vice President Tony Vine. The National Vice President tabled an amendment to his motion and supporting policy to reflect that the commemoration be at a suitable location, not necessarily the Submariners Walk as it is now full. Life Member Kevin Hayton argued that the policy must be included in the constitution, however he was not supported in this view.

Amendment; Carried by simple majority.

Action 2025/5: National Secretary to amend the draft policy on Recognising Life Members to reflect the amendment, National President to approve.

c. Motion 3. Amendment to By-Law, removing the requirements that dictates that all Branches and National must use "Law and Procedures at Meetings" by P Joske at SAA meetings. Submitted by National Vice President Tony Vine. Life Member Kevin Hayton objected to the wording of conducting meetings ethically and fairly and proposed an amendment to the motion reducing the change to "The conduct of meetings at all levels of the Association, be consistent with the SAA Constitution, By-Laws and standing Orders. NSW Member John Chambers spoke against the amendment as he considered that it conflicted with the requirements of the NSW Incorporations Act. Kevin Hayton's amendment was put to the vote and passed; the amended motion was then voted on and passed.

Amendment; Carried by simple majority.

**Poll;** 45 For, 3 Against **Amended Motion**: Carried

**Action 2025/6:** National Secretary to amend the National Constitution to reflect changes passed by motion and issue Change 8 to the National Constitution.

d. Motion 4. Re-instatement of the" Members only" section of the SAA National Website. Submitted by NSW Member Kevin. Life Member Kevin Hayton spoke to his motion arguing that we should be able to go onto the National Website and look up the details of any member, who on their original SAA membership application, had stated they were happy to have them released. The National Secretary opposed the motion on the grounds that having a "member only" section exposed the SAA to an unacceptable risk that Personal Identifiable Information (PII) could be hacked and appear on the Dark Web. As the SAA National is not an incorporated body this could expose the National Office Bearers, particularly the Webmaster, to litigation. He was supported in his argument by the webmaster, Bob Hendrie. He further explained that the website already contains a statement that any member who wants to obtain the contact details of another member, can contact either the National Secretary or the Membership Officer (Dave Bryant) who will contact that member to confirm they are happy to have their details released. The webmaster stated he will create a form on the website to facilitate such requests. The Motion was put to the vote, and it was not supported by the members.

#### 11. **General Business**

a. The ACT President, David Strangward briefed the membership on the ACT Branch's proposal to host SUBCON in 2026. The proposal is;

- SUBCON is to be held late October early November 2026 to avoid festivals and Parliamentary sitting weeks.
- The Committee will approach the Australian War Memorial (AWM) to request that a submariner be the subject honoured at the Last Post Ceremony on the Friday Evening.
- A Meet & Greet function on the Friday night. Note the original plan was for the Meet and Greet to be held at the Canberra Services Club, but it has recently burnt down. New venue to be advised.
- Saturday Dinner. To be held at the AWM.
- That CN be invited to attend.
- b. The National Secretary briefed the meeting that the Holbrook RSL were planning a large event in June 2027 to commemorate the placing of Holbrook in the park. This event has the potential to suck large numbers away from a full SUBCON that year. The National Committee are liaising with Holbrook RSL to piggyback on their planned functions. This means that the Holbrook RSL will organise the social events, which the SAA will advertise. The SAA will hold the AGM as usual on the Sunday morning.

**Action 2025/8:** National Secretary to liaise with Holbrook RSL on Otway commemorative weekend and provide updates to NC and members.

- c. The National Secretary advised members about John Goss's book on submarine Chefs. Details are on the SAA Website.
- d. Paul Gale briefed the members on his PHD which will be about submariners, rather than submarines.

### 12. Triannual SAA Executive Elections.

The Acting Secretary advised that as only one nomination had been received for each of the four elected positions on the National Executive, voting was not required. All four nominees are either Financial or Life members of the SAA and the Returning Officer has certified that their nominations were constitutionally valid.

The Returning Officer, Kevin Hayton declared that the SAA National Executive for 2025-2028 will be:

14. The National Secretary reminded all those present that the decisions made at the AGM were only provisional as there was not a quorum at the AGM. The decisions will remain provisional until ratified by a majority of SAA Branches within the next three months.

**Action 2025/9:** National Secretary to liaise with the Branch Secretaries to ensure that the minutes and decisions are reviewed by branches in a timely manner and that the National Executive, and the members be formally advised of the results of their review.

15. There being no further business the President thanked the members for attending and declared that the meeting was shut and clipped at 1200.

## SAA President Report 2024-25

I am sure all who attended would agree that we had a great SUBCON in Qld last year and the hard work of the team in Qld ensured all had a great weekend. With SA having to withdraw from hosting SUBCON 2025, I would like to thank NSW for stepping in at short notice to host this year's event.

I feel that this may happen more, as our numbers dwindle, and the committees struggle to get assistance from their respective members to organise a SUBCON. Of course, I do understand that the cost of hosting the event and the increasing price of travel is also impacting on members being able to commit to attending.

On the National front, we have the SAA website back up and running and I would like to acknowledge the work of Bob Hendrie as he works to continually improve the site. You would also notice that our Webmaster is updating the site regularly to include a number of interesting submarine articles and artefacts.

Tony Vine has also continued to assist in updating the Eternal Patrol page, on the site, that had a number of inconsistencies and incorrect information. The National Executive have also issued a number of policies to assist Branch Secretaries in their duties. These include a SAA Policy document outlining what to do on the death of a member and I would encourage all to read this particular document to ensure your family know and understand your wishes when you pass, including the use of the White Ensign and applying for the Navy Bereavement Pin. The policies can be found on the SAA Website.

As I stated at last year's AGM the National Committee were keen to step away from holding submarine merchandise and going to a just in time ordering system. I also directed that anyone who wanted to utilise the site to advertise their goods had to meet the guidelines set out by Brand Navy. I am happy to say we now have a provider, that has met the requirements outlined, and their link is on the site for all members. It was also agreed that the provider would donate some of their proceeds to the SAA. The link will allow members to source SAA memorabilia from suppliers that have SAA Executive approval.

It is disappointing that we continue to receive negative comments from a few members sitting on the sideline, attacking not only the National Executive, but also at the state/territory branch executives. It is interesting that these members never seem to put their hands up to help or to take on a committee position. I do encourage all members to give constructive and appropriate feedback as it can lead to better outcomes for the SAA.

As I stated last year I believe that we need succession plans for the positions on the National Executive (and state branches) and I will be raising this again at the National Committee meeting during SUBCON. I would encourage anyone that would like to or have thought about nominating for a position to please give it some serious thought.

As always, I want to publicly recognise Ray Kemp and the DVA team lead by Andy Armes for their tireless work in representing submariners as they tread the tricky path of DVA. As Ray and the team have always said do not go it alone.

Of interest, RADM Buckley became DCN this year, which means both CN and DCN are submariners, which I think, must be a first. In addition, a number of senior submariners have also been promoted to Flag rank and have joined the AUKUS program. I wait with interest for the announcement of the CDF in the near future; as I am betting Mark Hammond, the current CN must be a front-runner.

We lost a number of our shipmates in the last year, and I would ask that we please keep in your thoughts those shipmates that maybe are doing it a bit tough and as always, if they need help remember it is just a call away. I would also ask that members ensure the validity of information when posting the passing of a submariner or member on social media as recently we had an example of misinformation on a member making all think that he had passed. I am glad to say that his passing was greatly exaggerated but in all seriousness, it could have caused considerable stress to family and friends so please check the info before posting.

I would like to also take the opportunity to thank the committee for their tireless and at times thankless work during the last 3 years. Committee positions are voluntary and are held by members who want to make a difference. They give up lot of their time to ensure that their fellow SAA members are connected and get the support they need during hard times. As I have stated this work is voluntary and most of the time thankless but without them there would be no association. Members should also be aware that a lot of the work the committees undertake at both branch and national is not publicised, for obvious reasons.

As always, please keep safe and remember there is always help at hand should you need it, even if it is just a phone call from an old shipmate.

Their passing is a reminder of the strong bonds within our community.

Despite these challenges, 2025 has seen significant progress in strengthening the Association's foundations. A major focus has been on formally documenting how the Association is run. We have developed and published a suite of policies on the National Website to provide clear guidance for members assuming new roles at both the National and Branch levels, ensuring consistency and effectiveness in conducting our business.

Two of these policies deserve special mention:

Firstly, the policy on the passing of a member, indeed of any submariner. This outlines the crucial steps to be taken: informing the National Treasurer, Secretary, and Membership Officer so our records are accurately maintained. Furthermore, it enables us to offer meaningful support to the family, including the presentation of "Dolphin Poppies" and the inclusion of our departed shipmate on the Eternal Patrol Page. This year, we have presented these tokens of remembrance to the families of most submariners who have passed since our last AGM. As the original batch of Dolphin Poppies, purchased by Rob Nichols in memory of his late wife, is nearly exhausted, the SAA National has purchased an additional 200. Most of these have already been distributed to Branch Secretaries to ensure they can be presented in a timely and respectful manner.

Secondly, the policy on welfare assistance. It is important to recognise that welfare is not limited to financial aid through the SAA Welfare Fund. It encompasses a broader duty of care: supporting members through illness, assisting with DVA claims, and helping navigate other personal issues. Each Branch should have a dedicated Welfare Officer who acts as the first point of contact. If you become aware of a shipmate in need, I urge you to reach out to your Branch Welfare Officer.

I would like to extend my personal thanks and pay special tribute to Bob Hendrie for his ongoing work in rebuilding our website and for his invaluable assistance in enhancing the Eternal Patrol page. I also extend my gratitude to David Bryant for his diligent work as our Membership Officer. Their contributions are deeply appreciated.

Looking ahead, the 2025-2026 period will see some subtle changes in leadership at both the National and Branch levels. I look forward to working closely with all members in my ongoing role and extend my best wishes to the incoming National Secretary.

## SUBMARINE ASSOCIATION AUSTRALIA TRUSTEE REPORT 2025- WELFARE SUCCESSOR FOUNDATION

FROM: Dave Bryant (On behalf of fellow Trustees Sid Czabotar and Kevin Hayton).

TO: The President, National Executive and Members.

I wish to confirm that the 12-month period, 14<sup>th</sup> September 2024 to 14<sup>th</sup> September 2025 incurred an increase in funds of Nine Hundred and Seventy Dollars (\$970) in the General Account as there have been no calls on the fund over the reporting period.

Our total expenditure from 16<sup>th</sup> August 2022 to the present was Sixteen Thousand, Three Hundred and Sixty-Eight Dollars, Seventy-One Cents (\$16,368.71).

The Income earned over the last 13 months was mitigated by the very generous donations of Two Thousand, Six Hundred and Seventy-Five Dollars (\$2,675). from individuals which is detailed as follows:

Of note is the amount donated by the SAA ACT Branch of Five Hundred and Twenty Dollars (\$520) in memory of their esteemed Treasurer and SAA National Member, Peter (Bogey) Knights, who sadly passed away suddenly on Thursday 07<sup>th</sup> August 2025.

No rollover to the Current Account from the Term Deposit Account was made, as it was determined that sufficient funds were available in the Current (Cheque) Account to meet any member needs.

Importantly for those contemplating donating, the Foundation is Tax-Free and is a registered charity with the Australian Charities and Not-for-profit Council (ACNC), and as such donations are tax deductible.

I would like to remind everyone that our majority membership is getting older, and I would contemplate an increased call on the fund to help those members in dire need or in an emergency in the future. Also, please remember the Welfare Fund when considering your will beneficiaries.

The Foundation is, we believe, healthy with total assets as of 14<sup>th</sup> September 2025 of One Hundred and Seventy-Six Thousand, Five Hundred and Fifty-Two Dollars Thirty-Three Cents (\$176,552.33), of which Fourteen Thousand, Eight Hundred and Thirty-Eight Dollars Seventy-One Cents (\$14,838.71) is in the current account and is immediately available if required in support of our members.

The sum of One Hundred and Sixty-One Thousand, Seven Hundred and Thirteen Dollars Sixty-Two Cents (\$161,713.62) is held in the Term Deposit Account to maximize and consolidate interest payable.

Interest from our Term Deposit is currently earning 4.20% Interest Compound for a current term of twelve months, which is due for renewal 22<sup>nd</sup> March 2026. This interest rate was the best achieved by negotiation with the CBA and is comparable with rates offered by the other banks. It is foreseen that with interest rates decreasing over the next twelve months or more, a less favorable interest rate for future term deposits is inevitable.

On behalf of my fellow Trustees, I therefore table this Annual Report of the SAA Welfare Foundation
